If the documentation included in Cultural Resource Management Report 05-16-2305 is consistent with the final proposed action and site 05-16-0430 is determined not to be eligible for the National Register of Sites due to lack of site integrity, this project will be in compliance with Section 106 of the National Historic Preservation Act.
